THE CENTER OFFERS DENTISTRY SERVICES INCLUDING EMERGENCY TREATMENTS, PREVENTATIVE AND RESTORATIVE SERVICES, AT RATES BETWEEN THE 30TH AND 35TH PERCENTILE OF AVERAGE PRIVATE DENTAL PRACTICES ACCORDING TO THE NATIONAL DENTAL ADVISORY SERVICE COMPREHENSIVE FEE REPORT. WE SERVED 1,367 FAMILIES IN THE CLOTHES CLOSET WHO ACCOUNTED FOR 4,544 PEOPLE.
