Entering 2021, after an overwhelming 2020, we all felt relief. We began what we thought would be the new normal. However, less than 6 weeks into 2021, the ice storm hit Texas. At that point, we felt that it could be another challenging year. The year progressed with so many ebbs and flows, our staff learned to adapt quickly to new situations. YOU and YOUR support remained constant and saw us through the uncertain times.

Our Dental Center staff continued using the required PPE to keep them safe, all Manos de Cristo staff were vaccinated, and the Dental Center continued with the required CDC protocols. Patients returned for regular procedures and we were able to see 14,042 patients in 2021!

Our Education classes remained online throughout the year, allowing Manos to use volunteers from different parts of the country. We continued to refine, and improve our classes and students greatly benefited from the continuation of support needed to succeed in either ESL classes, Computer Literacy, or to obtain their Citizenship goals.

Finally, the cost of living has become a huge factor for our clients who utilize the Food Pantry and Clothes Closet. Multi-families per home has now become the norm as people struggle to pay rent, utilities, and other costs associated with living in Central Texas.

Our clients need you more than ever! YOU can ensure that the most vulnerable in our area continue to receive the help they need to thrive in our community. We are grateful for YOUR friendship and continued support of keeping people healthy in our community.

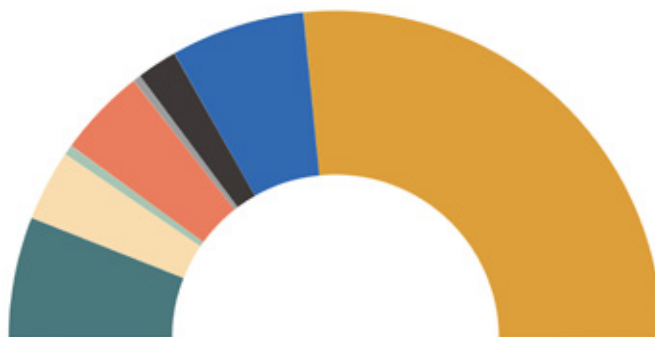

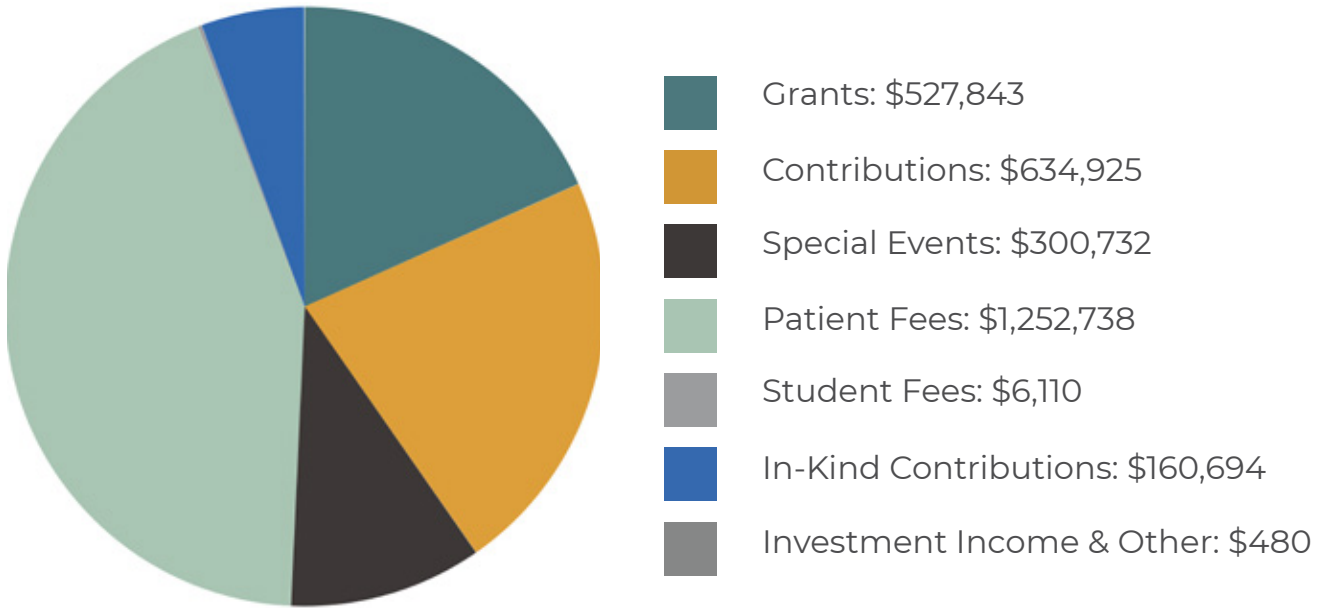
BACK-TO-SCHOOL PROGRAM

Manos de Cristo collaborated with Foundation Communities and school counselors to distribute backpacks filled with school supplies to children in need.

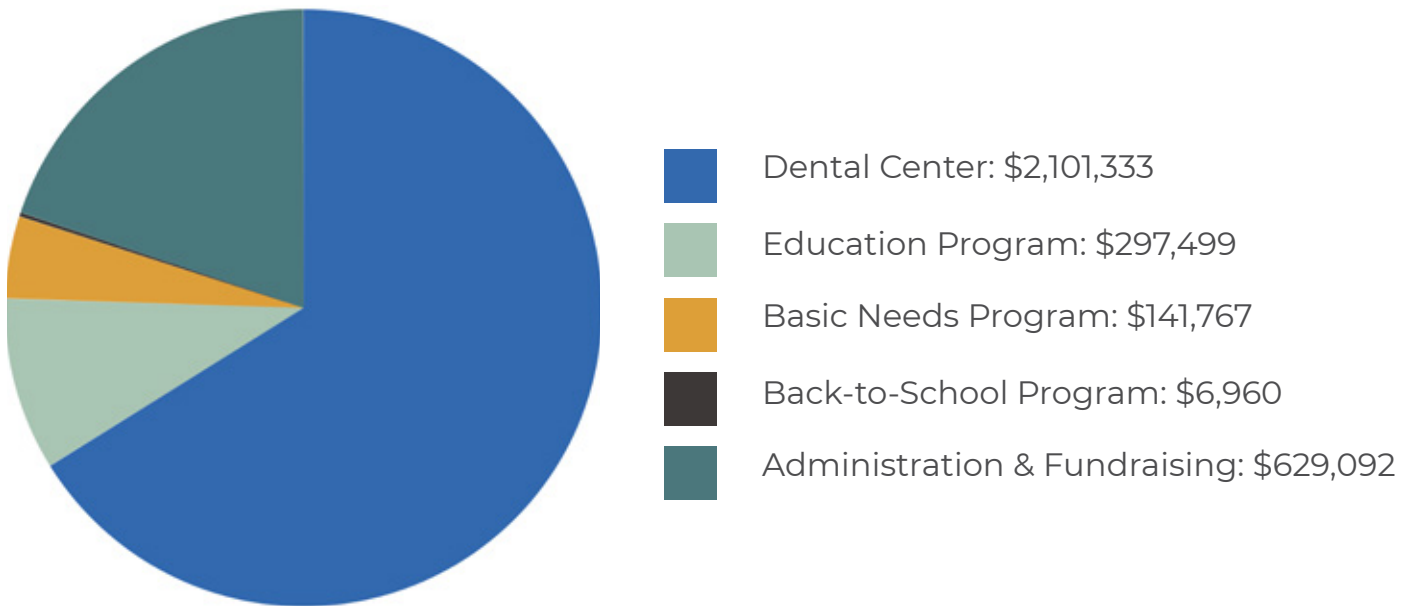
